Minutes for the Ordinary Meeting of Red Lodge Parish Council held on 8th September 2015 at the Millennium Centre, Red Lodge, commencing at 7 pm.

Guest Speakers or Reports

Police

The Police were invited but for whatever reason, Becky failed to attend.

District Cllr Carol Lynch

Cllr Carol Lynch informed the meeting that the consultation process on the local plan will be held on 16th September 2015 at the Sports Pavilion from 4 pm until 7 pm.

The signage to the Millennium Centre was discussed and the meeting was informed that a plan of action was to be arranged by "Linda".

The smells of raw sewage were discussed and it was deemed that the reply from Anglian Water was not adequate.

County Cllr Lisa Chambers

The August report was forwarded, there had been two speed checks undertaken along Hundred Acre Way. The first was a non visible speed check, the second was a visible speed check when all vehicles were reported to have been travelling between 10 and 25 miles per hour. It was noted that Police Enforcement is not as active at the present time, as it has been in the past.

Cllr Chambers was asked why was speed the issue, when obstruction and dangerous parking were the probable causes of the recent serious accident. Cllr Downs objected the reasons being given as speed as she felt that this was not the issue.

Cllr Rankin asked why not paint double yellow lines along both sides of the road on Hundred Acre Way?

It was then mentioned that white lines may be an option to which Cllr Chambers stated that she will continue to work with the Police to find solutions.

County Cllr Lance Stansbury

Cllr Stansbury raised the issues on the problems in respect of the sewers. He stated that all of the pumps within the vicinity of Red Lodge have been upgraded, however Herringswell is still an issue.

Copies of Clive MacLeod email in respect of this issue will be forwarded by the Parish Clerk to Cllr Stansbury.

The devolution Agenda was explained by Cllr Stansbury to the Parish Council and members of the public. A survey is being undertaken which highlights education, parking and public transport.

Clive MacLeod posed a question to Cllr Stansbury regarding the Anaerobic Process Plant issues. Clive MacLeod felt that the FHDC's response was totally inadequate. It was noted that an EIA (Environmental Impact Assessment) on this issue, had been requested in writing by Cllr Tim Burrows. Cllr Stansbury confirmed that he felt a full hearing was necessary.

Cllr Carol Downs asked why FHDC were unable to make a donation. She was informed that FHDC only donate to "kick start" funding. However, on this occasion it was felt that an exception can be made and it was agreed that £450 would be provided. In addition, RLPC agreed to an additional £250 donation.

To discuss the ongoing problem of dog fouling in the village. In particular, the wooded area and bridle way at the end of Buddleia Way.

It was agreed that dog fouling is still an issue within the surrounds of the village and that an additional dog bin be installed by the Bridle Way at the end of Buddleia Way.
