**Welcome and apologies for absence**

Apologies were received from Cllr Debbie Rankin and DCllr Lance Stanbury.

**Declarations of interest and Applications for Dispensation**

None.

**Public Questions on any items on the Agenda and opportunity to raise Agenda items for future Meetings.**

A member of the public stated that the 2013 Vision for plans for the Millennium Centre, never received any feedback.

A member of the public put a question of why there never seemed to be any consultation from the District Council to the Parish Council, in respect of Parish matters.

A member of the public stated that the plans by developers, which were recently shown as a Consultation included a Travelers' Site and asked for clarification, County Cllr Robin Millar explained the Planning Application process. He also stated that there was a further meeting planned in the near future. He emphasized that at this meeting the first preference will be to ensure the developers are in consultation with the Parish Council.

**To discuss the planning application DC/16/1188/OUT in respect of Outline Planning Application (Means of Access to be considered) 4no dwellings (demolition of existing bungalow) Location – 66 Turnpike Road, Red Lodge.**

The Parish Council's response to the above application was no comment.

**Additional Planning Application:**

**To discuss the planning application DC/16/1605/HH**

**Location – 21 Blackberry Way, Red Lodge.**

The Parish Council's response to the above application was no comment.

**To discuss the Retrospective Minutes of a previous meeting held in July 2016:**

**The quote for the maintenance of the Rugby pitch and 2 Football pitches, to aerate on 2 occasions per year at a cost of £142.57p. To scarify the 3 main pitches on one occasion per year at a cost of £182.16p. To mark out the 3 main pitches on one occasion per year at a cost of £298.69p. To supply and apply fertiliser on 1 occasion per year at a cost of £761.85p.**

**Petanque Court – to strim existing weeds and spray of as requested at a cost of £62.50p.**

**The quote for the MUGA maintenance. To provide a deep clean of the MUGA on 1 occasion per year at a cost of £639.00p. To spot treat weeds which appear on the courts with herbicide on 6 occasions per year at a cost of £130.00p.**

**To purchase a chain pulled drag brush for ongoing maintenance of the MUGA at a cost of £444.00p.**

**To discuss the Heatherset Way play area. To remove existing sleepers and jump poles, supply and spread top soil at a cost of £575.00p.**

All of the above was agreed by the Parish Council.
